### **Foundation Funds at Work**

#### Making a Difference in Dallas

It's been a year of giving! This year, your gifts enabled the Foundation to distribute \$43,000 in grants, award 32 scholarships to 18 students totaling \$38,800 and give an additional \$30,000 in support of community activities and programs, including the high school turf project. In November, the Foundation awarded an additional grant to Polk County's Resource Center to address immediate urgent needs.

We're pleased to share a few highlights from our 2018 grant recipients.

The Dallas Youth Garden continues to grow. Nine interns delivered over 3,200 pounds of fresh produce to the Dallas Food Bank and Willamette Valley Food Assistance Program.

Dallas Food Bank is serving more families this year compared to last; the number of homeless families has doubled. The Food Bank prepares approximately 289 food boxes per month.

Friends of the Dallas Library were able to purchase 37 Large Print books and 32 Audio Books, serving the needs of seniors, disabled and the visually impaired.

Liberty House is set to open a clinic here in Dallas to better serve the needs of children with concerns of abuse and neglect.

Quality of life has improved for residents of Dallas Retirement Village with two new programs, aromatherapy and virtual reality travel.

Polk Community Free Clinic has provided 440 medical and mental health appointments, nearly a 25% increase from 2017.

Family Building Blocks Therapeutic Classroom is making a big impact on at-risk toddlers, such as Kieler. Born two months premature, he had significant health and behavioral challenges. With his extreme sensitivity to noise and new environments, he cried constantly, was unable to regulate his emotions and did not interact with teachers or other children. After six months in the program, his progress has been truly remarkable. He rarely cries. He uses sign language and verbal cues to communicate with his teachers and peers. He's becoming a happy, welladjusted little boy.

Recently, Dallas Community Foundation and Dallas Education Foundation granted \$7200 for 14 projects for Dallas School District students. An update from Amy Morrison, a teacher at LaCreole who received a grant last year, "It's been so wonderful to provide the 8th grade STEAM students with the tools, equipment and materials necessary to work on their projects and tasks. The concept of building and design became more real and meaningful when students were able to assemble and create with quality materials, instead of prototypes with popsicle sticks and tape."

### **Supporting Literacy in Dallas Schools**

SMART Program Inspires a Life-Long Love of Reading

Maria is a happy young girl, with an infectious smile. She loves school but struggles with reading. Every week, she looks forward to a special reading program called SMART. She gets to read with a very nice lady. She especially loves the special days when she gets to pick out a book to take home. She's becoming a better reader and is very proud of her growing collection of books at home.

SMART, Start Making a Reader Today, is a statewide program that works with local schools to help kids reach the 3rd grade benchmark for reading. In Dallas, the program currently serves 40 students at Lyle and Oakdale Heights Elementary Schools. The students, ranging from kindergarten to 3rd grade, are selected by their teachers. One Dallas teacher explains, "My student loves his time with SMART volunteers and looks forward to his reading time each week. He has benefitted abundantly from having a positive adult interaction."

Volunteer readers for the program are assigned two students for the program year. Each week they come in for an hour, spending 30 minutes of reading time with each student. There are currently 26 volunteers; 5 of these come in twice a week to serve the additional students. According to Michael Finlay, SMART Program Manager, more volunteers are needed. "SMART is committed to helping develop a love of books and reading with students in Dallas. We have two terrific site coordinators and a bunch of wonderful readers. We still have many students waiting to be read with at both schools. We

would love to see 10 new volunteers join us in the New Year so that we can reach out to more students with shared reading experiences and the joy of a good book."

To encourage reading at home, an activity essential to fostering good reading habits, SMART students select two books each month to keep. A significant percentage of SMART students are from families who have few, if any books in the home, and are much less likely to engage in reading outside of school. Book giveaway days are often the best part of SMART for students. They get to choose their favorite from among the books they have enjoyed reading each week with their volunteer. Together with the volunteer, students personalize the book with a name plate before it is taken home to enjoy.

Great care is put into the book selections. A committee reviews the books to ensure they are positively affirming, inspiring, and age and reading level-appropriate. This year, DCF has provided grant funds to purchase 351 books for SMART students at Lyle and Oakdale Heights Elementary Schools.

Dallas Community Foundation is pleased to support the SMART program in Dallas, enhancing the efforts of volunteer readers that inspire and motivate students to grow as readers and increasing students' access to books. Literacy skills are critical to a student's success in school and throughout their entire adult life.

### **DCF Announces 2019 Grant Distribution**
